The E.O.I. should be submitted **in sealed envelopes** addressed to State Medical Commissioner, E.S.I.C., Regional Office, Panchdeep Bhawan, J.L. Nehru Marg, Patna-800001 so as to reach by **12.00 noon of 21.03.2016**. And E.O.I will be opened on **21.03.2016 at 3:00 PM** in the Regional Office, Panchdeep Bhawan, J.L. Nehru Marg, Patna-800001.

A list of E.O.I. received would be prepared and those found eligible for issue of application form would be issued Application Form within 15 days of opening of E.O.I. and applicants would be required to apply again in the prescribed format within next 15 days. Based on scrutiny of applications/satisfactory condition on inspection of the Clinic/Nursing Home/Hospital, empanelment of doctor/nursing home/hospital would be decided. Agreement would be signed and allotment of Insured Person family units of the area would be made to selected doctors for providing the Primary Medical Care facilities.

IMP Doctor will be paid a fixed capitation fee @ Rs.300/- per Insured Person/IP family unit per annum (maximum allotment of 2000 IP family units per doctor), along with other remuneration, as per rule on pro rata basis per month. State Medical Commissioner, E.S.I.C., Bihar Region, Patna will have the sole authority to accept or reject any application, if he is satisfied with the cause to do so, without assigning any reason.
