- c) Certificate to the effect that the candidates belonging to Scheduled Caste/ Scheduled Tribe/ Other backward class, as the case may be, specifically as per the prescribed proforma.
- d) Discharge certificate/ book along with relevant documents in case of a candidate belonging to Ex-serviceman category.
- e) Candidates seeking age relaxation as Government Employee/ ESIC Employee shall have to produce Service Certificate for verification.
