6. **Bidder (s) can inspect the articles/items between 9.30 AM to 5.00 PM in the above mentioned address from 30.05.2018 to 19.06.2018** in regard to the conditions, quality etc. of the articles/items and satisfy themselves before submitting their offer by the date and time specified.
7. Any tax is leviable shall be paid by the successful bidder.
8. All articles/items will be sold on "AS IS WHERE IS BASIS" (Lot wise) will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quality of the articles/items proposed to be auctioned.
